Scope of Works

SENTECH requires the appointment of a service provider for 24/7-Armed Response Security services at Sentech SOC Ltd Port Elizabeth, Greenbushes site for a period of three years. The service provider must monitor, coordinate premises from possible break-ins and theft. The service provider must accompany personnel to and from our office at night when required.

1. Background

Sentech Port Elizabeth request for the procedure of a 24/7-armed response security services at our Sentech Greenbushes site as the current contract is due to expire.

We want to take the necessary safety and security measurements and secure and safeguard the company's property, assets, and personnel.

The risk of not having the 24/7-armed response security on site will compromise the security of the site and its assets and the safety of Sentech personnel. Secondly, in the event of a break-in, the services will be disrupted affecting the SLA's for the customers.

We are calling on organizations with the relevant skills and experience to render its services by monitoring, coordinating the premises and accompany personnel at night when required with 24/7 security which will minimize or eliminate future break-ins and property vandalism.

2. Scope of Works

The successful applicant will:



- Supply and installation of radio system for monitoring.
- Remote monitoring and armed response of the premises including weekends and public holidays.
- Patrols and escorting of Sentech personnel to site on request.
- Liaise with the Manager or Sentech Standby person of Sentech Port Elizabeth regarding the safety and security measurements of the property and premises when alarms including false alarms are triggered.
- Implement the necessary safety and security protocols when an incident presents itself.
- Provide a detailed report in the event of any breech of safety and security of the property and premises.
